



RULES

Art. 1 - The **ALPECIMBRA FIS CHILDREN CUP – 55° Criterium Internazionale Giovani FIS** is a FIS international Giant Slalom, Slalom Event for U14 and U16 competitors representing their National Ski Association.

The U16 competitors will race the Giant Slalom and the Slalom in two runs. The U14 competitors will race the Slalom in two runs and Giant Slalom only in one run. The **ALPECIMBRA FIS CHILDREN CUP** is organized by the Sport Association TTS, the Alpe Cimbra Tourist Board, the Polisportiva Alpe Cimbra and Trentino FISI Committee.

Art. 2 (ICR607.3)

The male and female categories for 2025/2026 season are:

U14: competitors born in 2012/2013

U16: competitors born in 2010/2011

Art. 3 - The race slopes will follow the rules and will have the following technical data:

SLALOM (ICR 800)

- U14 – U16
- 2 (two) runs
 - Vertical drop 100 m. – 160 m. (ICR 801.1.3)
 - Direction Changes: 32% to 38% of the vertical drop, +/- 3 (ICR 801.2.4)

GIANT SLALOM (ICR 900)

- U14
- 1 (one) run (ICR 901.1.4)
 - Vertical drop 200 - 350 m. (ICR 901.1.4)
 - Direction Changes 13% to 18% of the vertical drop (ICR 901.2.4)
- U16
- 2 (two) runs (ICR901.1.4)
 - Vertical drop.200 - 350 m. (ICR901.1.4)
 - Direction Changes 13% to 18% of the vertical drop (ICR 901.2.4)

The competitors are bound to put on a homologated helmet for the competitions that meets the FIS Equipment Specifications. (ICR 907)

ICR art. 3.5.1.3 Recommendation for specifications for Children.

Children U12, U14 and U16 should use back protectors.

Art. 4 –Only official representatives entered by each National Ski Association can participate into the ALPECIMBRA FIS CHILDREN CUP. Each team must participate with a maximum of 10 athletes, 6 in the U16 category and 4 in the U14 category. Not more than 4 athletes of the same sex must be registered within each of the category. (ICR 608.4.1)

The organizing nation is entitled to a double quota that is maximum 20 competing athletes.; The 2nd teams will compete separately to conquer the ranking by Nations.

Each National Team must be composed of the same athletes in every race of the event.

All the competitors must be members of their own National Ski Association. They must be insured and hold a written consent signed by their parents and an identity document. The National Ski Association must consent to their participation and guarantee that the regulation above is observed.



The Organizing Committee will allow maximum of 10 (ten) National Ski Associations to inscribe a second team applying the same rules as for the first one. (see art. 4).

Both teams will be qualified separately in the classification for Nations as Team "A" and Team "B".

Those Nations who would like to inscribe a second team must do it with the preliminary entry before February 1, 2026.

Art. 5 - The classification for each Nation is made according to the total scores given to the single athletes classified in each competitions, both boys and girls as follows:

1 st classified	25 points	9 th classified	7 points
2 nd classified	20 points	10 th classified	6 points
3 rd classified	15 points	11 th classified	5 points
4 th classified	12 points	12 th classified	4 points
5 th classified	11 points	13 th classified	3 points
6 th classified	10 points	14 th classified	2 points
7 th classified	9 points	15 th classified	1 point
8 th classified	8 points		

In case of a tie, the Nation whose athletes obtained the most victories (or most second or third places in case of a tie) is declared as the winner.

Art. 6 - There are individual awards for the slalom and giant slalom, boys and girls.

CUP AND MEDAL	1 st classified in each category
MEDAL	2 nd classified in each category
MEDAL	3 rd classified in each category

Art. 7 - The ALPECIMBRA FIS CHILDREN CUP is awarded to the Nation who wins the combined classification.

Art. 8 - The Organizing Committee is supervised by F.I.S. and F.I.S.I. Alpine Technical Delegates.

Art. 9 - The final entry form must be filled in and addressed to:

and must arrive not later than **8 p.m.** on the **March 1st 2026**. Owing to the large number of competitors, the Jury keeps strictly to this date except in the case of postal delay. A preliminary entry form must be sent, by each National Ski Association not later than **February 1st 2026**. Entries must be sent only by the National Ski Association concerned. The National Ski Associations, are asked to make a list of their entrance according to their ability; the best competitor in the first place, followed by the others in order of merit. The Jury will decide the starting order groups on the base of this information.



Art. 10 - As the draw will be made by computer, it is absolutely essential that the athletes are listed on the entry form in the order you wish them to be entered for the draw.

No changes will be accepted during the team captains meeting.

It is also essential that the names of the competitors are written clearly (typed or in capitals), indicating first the surname and then the name. If more than 15 nations have registered the following principles apply (ICR608.5).

Group 1:

The first group will contain one athlete from each nation registered. Each nation is allotted one start place only.

Group 2-3-4:

Same as group 1

Last group:

The last group will include, selected by drawing lots, the athletes who are part of the double quota of the organizing country and of the other countries that have entered a team B. If the organizing country puts in the field, beyond the double quota, an additional number of competitors, they will be draw in a special group after all the other groups.

Draws and Start Orders

At each jury meeting (March 4 and March 5), athletes will be drawn and the start orders for the following day will be established. Team captains may make changes to the merit groups before the TCM on March 5, from 3:45 PM to 4:30 PM, at the race office.

All teams will be required to pay a deposit of €100 for the distribution of race bibs, which will be refunded only when all bibs are returned to the race office at the end of the event.

Art. 11 - Any protest must be presented as set out in ICR art. 640-647. They must be written and addressed to the Jury.

Art. 12 - All the National Representatives will have to stay **in the affiliated hotels and residences indicated by the Organizing Committee** at their own expense at the prices and conditions here below:

The Organizing Committee will provide **FREE hot lunches vouchers and ski passes ONLY to athletes and coaches (max 10 + 4) for the days from Wednesday, March 4 to Friday, March 6 (3 days) who have booked via email to incoming@alpecimbria.it in one of the hotels/residences partners)**

Every delegation must take over the expenses for travel, transfer from airport to the hotel and vice versa and **tourist tax (€ 2,00 per person/day > 14 years old in 3 star &/or 3***S hotels and residences)** and any extras not included in the price of the stay, to be paid in the hotel.

HOTEL

- BED & BREAKFAST: **€ 55,00** per person /day

- HALF BOARD: **€ 65,00** per person / day (included tap water for children and ¼ lt. house wine only for the adults at dinner time)
